Personal Data Processed, Purposes of Processing, and Legal Grounds

Your personal data is processed within the scope of the purposes and legal grounds specified below:

- **Membership and Service Processes:**
Your data such as full name, Turkish ID number, place/date of birth, contact details, financial data, and signature circular are processed for the completion of membership procedures, application (app) activation, and provision of services, based on the legal ground of "being necessary for the establishment or performance of a contract."
- **Marketing and Announcements:**
Location-based notifications, event announcements, and campaign communications are carried out based on your "explicit consent."
- **Operational Development and Analysis:**
Member satisfaction surveys, complaint/suggestion evaluations, and business process improvement activities are conducted within the scope of the "legitimate interest of the data controller," provided that your fundamental rights and freedoms are not harmed.
- **Security:**
Camera recordings in service buildings and facilities are processed for the purpose of ensuring public and workplace security, based on the legal grounds of "legal obligation of the data controller" and "legitimate interest."
- **Legal Obligations:**
In processes related to the exercise of rights arising from legislation and responding to requests from public authorities, your data is processed based on the legal grounds of "being explicitly stipulated by law" and "fulfillment of a legal obligation."

Transfer of Personal Data

Your personal data may be transferred for the realization of the above-mentioned purposes to:

- **Authorized Public Institutions and Organizations** (such as Ministries, BTK, İŞKUR, judicial authorities, etc.) in accordance with legal requests and applicable legislation,
- **Business Partners and Suppliers** (service providers, program partners) in a limited and purpose-specific manner,
- **Cloud Service Providers (Domestic)** for data storage purposes.

Methods of Collecting Personal Data

Your personal data is collected through the website, mobile applications, SMS services, physical forms, camera systems, telephone, tablet, and social media accounts, by fully or

partially automated means or by non-automated means provided that it forms part of a data recording system.

Your Rights as a Data Subject

Pursuant to Article 11 of KVKK, you have the right to:

- Learn whether your personal data is being processed,
- Request correction, deletion, or destruction of your data,
- Request compensation for damages in case you suffer harm due to unlawful processing.

Your requests will be finalized within 30 days at the latest.
